

# A Subclass of Subexponential Distributions

## Abstract

In this presentation a class of heavy tailed distributions is used to provide simple asymptotics for the ruin probability in the classical risk model under a constant interest force. We examine the properties of this class in comparison with the standard subexponential distributions.
