

On some path-dependent correlation models in risk theory

Abstract

We investigate multi-dimensional ruin probabilities and optimal reserve allocation in the case where correlation between lines of business changes over time and is path-dependent: correlation crises or correlation crashes may occur and their occurrence may depend on the history of the risk process. We compare our results to the ones obtained in more classical Markovian environment models.
